Policymakers Ask for Mayo Input on Health Care Reform

Last week, Denis Cortese, M.D., president and CEO of Mayo Clinic, and Jeff Korsmo, executive director of the Mayo Health Policy Center, met with members of Congress and the incoming administration about the need for health care reform. The Mayo Clinic leaders met with more than 15 key leaders, including House Speaker Nancy Pelosi, D-Calif.; Sen. Max Baucus, D-Mont., chair of the Finance Committee; Rep. Pete Stark, D-Calif., chair of the Ways and Means Subcommittee on Health; and Jeanne Lambrew, newly appointed deputy director of the White House Office of Health Reform.

"They all want to hear more from us as they move forward on reform," says

Dr. Cortese. He added that members of Congress are especially interested
in hearing from physicians. "We must keep the momentum going by sharing
our perspective as policy positions are put forth."

Key issues of current focus include health care information technology, expansion of public insurance programs to cover the uninsured, and the concept of a U.S. Health Board.

- Create a reliable repository for patient information that providers across the nation could access.
